Conditions & Requirements

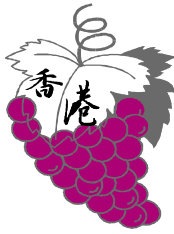
Membership requirements: (either or one of the following)

- Recommended by a Food & Beverage Organization management
- Recommended by Association existing members and verified by committee members.
- Valid upgrade from student membership.

The Association's Committee reserves the right to reject or hold any application.

Obligations and rights

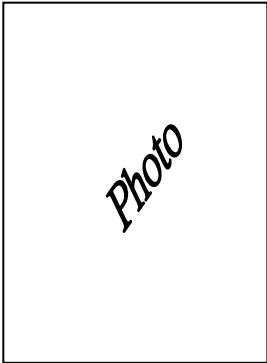
- Clear distinction as a responsible and professional sommelier.
- The right to use the Hong Kong Sommelier Association's logo for publicity purpose.
- The right to participate in all training programs and activities from the Association.
- Members are expected to be present in at least 50% of the Association's activities within the membership period. Failure in doing so without reasons will result in suspension of membership for 6 months.
- Non-compliance of the regulations may result in expulsion of membership by the Association committee.
- Any dismissed member cannot rejoin the Association for a year.
- Members are forbidden to make use of the reputation of the Association to gain any benefit for his or her private business.
